- 1. RESIDENT COMMUTER** - provide copies of LIRR commuter ticket (i.e. weekly, or monthly pass), proof of residency within the Incorporated Village of Malverne, and vehicle registration.
NOTE: Malverne & Westwood Train Station, Lots 1 & 2, Lots 3, & 6 indicated by signage.
- 2. RESIDENT DAYTIME** - provide copies of proof of legal apartment residency within the Incorporated Village of Malverne and vehicle registration.
NOTE: Daytime parking is permitted only in Lot 5 (Village Hall).
- 3. RESIDENT OVERNIGHT** - provide copies of proof of legal apartment residency within the Incorporated Village of Malverne and vehicle registration.
NOTE: Overnight parking permitted in Lot 1 (Broadway), Lot 5 (Village Hall) Parking is permitted from 6:00pm-6:00am. Cars must be out of the Parking Lots by 6:00am.
- 4. NON-RESIDENT COMMUTER** - provide copies of LIRR commuter ticket (i.e. 10 trip, weekly, or monthly pass) and vehicle registration.
NOTE: Non-Resident parking permitted at Westwood Station, Lot 2 and Lot 3 indicated by signage.

Permits must be permanently affixed to your vehicle on the inside driver's side rear window. Permits placed anywhere else inside your vehicle or on the dashboard will be considered invalid and your car will be ticketed.

Applicant acknowledges and understands the above regulations. Applicant further understands that failure to comply with the regulations will result in a citation being issued by the Malverne Police Department. Repeated misuse of this permit may result in revocation of the issued parking permit.

Permit fees will be pro-rated after July 1st. Issuance of a permit does not guarantee a parking spot.
